2. Tanzania National Parks (TANAPA) has set aside funds for its operations during the financial year 2008/2009. It is intended that part of the proceeds of the funds will be used to cover eligible payment under contracts for the procurement of the above items.

3. Tanzania National Parks now invites sealed bids from eligible Suppliers of the above items

4. Bidding will be conducted through the National Competitive Tendering Method procedures as specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and is open to all Bidders as defined in the Regulations.

5. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of the Director General, Tanzania National Parks, Mwalimu J.K. Nyerere Conservation Centre/Building, Dodoma Road, P.O. Box 3134, Arusha from 08:00pm to 4:00pm on Mondays to Fridays except on public holidays.

6. A complete set of bidding documents may be obtained by interested and eligible Bidder from the office of **The Director General, Tanzania National Parks, P.O. Box 3134, Arusha-Tanzania** upon payment of non-refundable fee of **Tshs. 100,000** from 8:00 to 16:00 hrs local time from Mondays to Fridays inclusive except on public holidays. Payment should be made by Bankers Draft.

7. All Bids must be accompanied by a Bid Security/Securing Declaration in an acceptable form.

8. Bids duly completed and enclosed in plain sealed envelopes clearly marking the **TENDER and Lot Reference Numbers**, addressed to The Director General, Tanzania National Parks, P.O. Box 3134, Arusha, must either be delivered by hand or be sent by registered post/courier service so as to reach the Secretary, TANAPA Tender Board, before the deadline for submission of bids.

9. All bids in one original plus one copy properly filled in, and enclosed in plain envelopes must be delivered to the address in paragraph 8 above at or before *2:00pm on 04.12.2008*. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend the opening ceremony at TANAPA HQ in Arusha.

10. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
