#### **INVITATION FOR BIDS**

1. The **Tanzania National Parks (TANAPA)** now invites sealed bids from eligible firms registered in Tanzania to run the Twiga Hotel located 1km from the junction outside the Park Headquarters.
2. Bidding will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and are open to national Bidders only as defined in the Regulations unless otherwise stated in the **Bid Data Sheet**.
3. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of the **Tanzania National Parks, Mwalimu J.K. Nyerere Conservation Centre/Building, Dodoma Road, P.O. Box 3134, Arusha**, on Mondays to Fridays inclusive except on public holidays.
4. A complete set of Bidding Document(s) in **English** and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a **non-refundable fee of Tshs. 100,000**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **TANAPA**.
5. All bids must be accompanied by a **Bid Securing Declaration** in the format provided in the Bidding documents.
6. All bids in one original plus **one copy**, dully completed and enclosed in plain sealed envelopes clearly marked with the **tender reference number**, addressed to: - The **Director General, Tanzania National Parks, P.O. Box 3134, Arusha**,

delivered by hand or be sent by registered post/courier service so as to reach the **Secretary, TANAPA Tender Board**, before the deadline for submission of bids.

7. The deadline for the submission of the tenders is **14:00hrs** local time on **03.09.2008**. Bids will be opened immediately thereafter on the same day in the presence of interested bidders or their representatives who choose to attend the event at TANAPA HQ Board Room at the Mwalimu J. K. Nyerere Conservation Centre, Dodoma Road, Arusha.
8. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
9. TANAPA is not obliged to accept the lowest or any tender.
