**INVITATION FOR BIDS, TENDER No. 10 OF 2005/2006
(READVERTISED)**

1. Tanzania National Parks (**TANAPA**) is looking for eligible, reputable, and competent firm to contract for the Purchase and removing of **TEAK (*Tectona grandis*)** trees which line the eastern boundary of **Udzungwa Mountains National Park**. The work is estimated to include removing of **6863 trees**; that will result into approximately 6454.7M3 of timber.
2. The Director General of Tanzania National Parks (**TANAPA**) would like to invite sealed Tenders for the purchase and removing of exotic **TEAK (*Tectona grandis*)** trees.
3. Tendering will be through National Competitive procedure specified in the Public Procurement Act No. 21 of 2004, Government Notice NO 97 published on 15th April 2005, and is open to Tenderers operating and registered in Tanzania.
4. Interested Bidders may obtain further information and inspect the bidding documents at the office of the Secretary, **TANAPA Tender Board, Room No.40, 2nd Floor, TANAPA HQ, P.O. Box 3134, Arusha –Tanzania.**
5. A complete set of bidding documents may be obtained from the office of **The Director General, Tanzania National Parks, P.O. Box 3134, Arusha-Tanzania** upon payment of non-refundable fee of **Tshs 100,000/=** from **8:00 to 14:00 hrs** local time from Mondays to Fridays except on public holidays. Payment should be made by **Bankers Draft.**

Tenders dully completed and enclosed in plain sealed envelopes clearly marked “**TENDER No.10 OF 2005/2006 FOR PURCHASE & REMOVING OF TEAK TREES**” should be addressed to **The Director General, Tanzania National Parks, P.O. Box 3134, Arusha**, and be delivered by hand or be sent by registered post/courier service so as to reach the **Secretary, TANAPA Tender Board**, before the deadline for submission of the bids.
7. The deadline for the submission of the tenders is **14:00 hrs** local time on **09.04.2009**. Bids will be opened immediately thereafter on the same day in the presence of interested bidders or their representatives who choose to attend the event. The opening venue will be at Board Room, Mwalimu J. K. Nyerere Conservation Centre along Dodoma Road, Arusha.
8. Bids in electronic, telegraphic, telex, telefax, received late, received not sealed and not read out during bid opening ceremony shall neither be accepted nor considered for evaluation irrespective of the circumstances.
